PURPOSE

The 2018 Members' Juried Show provides all members of the Minnetonka Center for the Arts an opportunity to enter their work in a professional, juried exhibiton, and seeks to present a balanced representation of the talents and artistic interests of our members.

ELIGIBILITY

All members of the Art Center (current through June 22, 2018) are invited to submit up to 3 original works of art. Memberships may be initiated or renewed on the day of delivery.

PROCESS

- Deliver artwork on Tuesday, May 15, 9 a.m. 7 p.m. (FIRM)
- Jurors will meet on May 16-17.
- Accepted entries posted on our Exhibits webpage by 4 p.m. on May 18
- Non-accepted art pick-up: Saturday, May 19 (FIRM) 10 p.m. 2 p.m.
- Show closing pick-up: Saturday, June 23 (FIRM) 9 a.m. 1 p.m.

ENTRY FEE AND TAGS

\$10 for one piece, \$15 for two, and \$20 for three. Entry fee is payable in the gallery by cash or check, or at the front desk by credit card (Visa or Mastercard). Deliver your work to the Gallery and sign your exhibit contract. Inventory tags (below) must be filled out completely - both halves - for each entry (do not cut the double tag in half). For 2D work, attach tag to the back, and for 3D work, attach the tag to the bottom. You must include the retail sale price of each work. The Art Center reserves the right to reject work that has not been valued appropriately.

Complete both halves of one tag for each entry, up to three total. Do not cut the double tag in half.

AWARDS

Best of Show, Second and *Third* places will be designated, plus honorable mentions in major media categories.

WHAT TO ENTER

- All media 2D and 3D (except installation art) are eligible.
- Each member may enter up to three pieces of work.
- Works must be original, completed within the past 2 years.
- Work done in class must be executed solely by the student.
- · Kits are not allowed.
- Work shown at previous Art Center shows will not be accepted.

SALES & PROMOTION

All works must be for sale. The Art Center will retain a 40% commission on sales. Consent to reproduce images of works for publicity or educational purposes is assumed unless specifically refused in writing.

REQUIREMENTS

- All works must be ready to display.
- 2D work must be dry, framed (or gallery wrapped with finished edges for works on canvas) and securely wired for hanging.
 No sawtooth hangers.
- 3D work must be stable and structurally sound.
- · Acetate or shrink-wrapped work will not be accepted.
- · Work must be labeled clearly with tags.

LIABILITY

- Selected works will be insured from receipt through June 23, 2018.
- Works NOT selected will be insured through May 19, 2018.

DELIVERY & PICK-UP

Delivery and pick-up of all work is the responsibility of the artist. All packing materials must be removed from the Art Center by the artist at the time of delivery. The Art Center is not responsible for loss or damage to artwork not picked up during these times.
